Capital Levy: The Capital Levy is required to meet the costs of the Capital Program and to service Capital loans. It is charged on a *per family* basis. As the Capital Levy is a compulsory fee charge, Capital Levy payments made are therefore **NOT** tax deductible. Combined Marymount Primary / College families receive a 50% annual rebate on the Capital Levy.

P&F Levy: All funds collected are forwarded to the Association to support their annual student projects and fundraising activities. Combined Marymount Primary / College families receive a 50% annual rebate on the P&F Levy.

Student Levy: Used to cover Classroom Budgets/Stationery & Supplies; Educational Software; Printing; Photocopy charges; Resources for Music, Library, Art & Sports; Replacement & Maintenance of Air Conditioners & Technology Equipment including electronic whiteboards; Religion/Music/Sports Buses; Elective Sports; Incursions & Excursions
